TERMS & CONDITIONS

A. FEES

1. New students are required to pay all fees and deposits in full during registration.
2. All fees must be paid in full on or before the 15th day of the starting month of the 2nd and 3rd Terms respectively. Payment of the 1st Term fees must be made on or before November 15th of the preceding year of existing students. Late payments will be subjected to an administrative charge of RM100. The School reserves the right to offset the oldest owing.
3. Payment of fees is to be made via online transfer.
4. Students will be suspended from school if payment of subsequent Term fees are not made by the 15th of the second month of the Term. The suspension will be in effect until payment is made.
5. Parents who are unable to make their fee payment by the stipulated due dates are advised to write in or make an appointment to see the respective Principals before the due dates.
6. Students, whose 2nd and 3rd Term fees or deposits are not fully paid by the end of the relevant Term, would be considered terminated and all previous payments forfeited. These students vacancies will then be made available to others. Any admissions after the school academic year has started, will be charged school tuition fees effective from the month they enroll.
7. Students who withdraw before the end of the academic year will be charged tuition fees for the relevant Term of withdrawal.
8. Fees and charges are not transferable to another student, nor can they be deferred to another year or Term.
9. Canteen Fees, where applicable, shall be paid directly to the Canteen Operator.

TERMS & CONDITIONS

B. WITHDRAWAL & RETURN OF DEPOSITS

1. Deposit is refundable only upon parents giving six (6) months written notice of withdrawal.
2. Upon submission of the written notice of withdrawal, the child has to remain in the school for the 6 months period.
3. The Deposit cannot be used to contra any of the Term's fees or outstanding fees due.

C. LIMITED LIABILITY AND INSURANCE

The school holds insurance policies for accidents occurring on the school premises. The school and its holding company shall not be liable for any accident, injury or death resulting from an act of God, unforeseeable circumstances and/or acts, negligent or otherwise, of a third party within the school's compound or near its vicinity. The school shall be liable strictly only up to the limit of its accident insurance cover for any willful or negligent acts by its employees resulting in accident, injury or death. Parents/Guardians shall fully indemnify the school and its holding company against any accident, injury or death resulting from their own willful or negligent act or that of their children/ward or guests.

D. CHANGES TO RULES AND REGULATIONS

The School Board has the right to add, delete or change any of these rules and regulations without notice. Any changes to these rules and regulations shall be considered to have been circulated to all parents and by a copy of the revised Terms and Conditions of Enrolment being posted on the school's noticeboard. These changes to these rules and regulations shall be immediately binding on parents/guardians and students.
